**SUBJECT: Public Health Warning Against the Purchase and Use of the Non-Compliant Cosmetic Product "FAIRNESS & FLAWLESS SGT. AT ARMS WHITENING DEO SPRAY"**

The Food and Drug Administration (FDA) warns the general public from purchasing and using the non-compliant cosmetic product, "FAIRNESS & FLAWLESS SGT. AT ARMS WHITENING DEO SPRAY" with details specified below:

The Food and Drug Administration has verified that the abovementioned product is **NON-COMPLIANT** through its postmarketing surveillance (PMS) pursuant to Book I, Article II, Section 2 of the Rules and Regulations Implementing Republic Act No. 9711, otherwise known as



the "Food and Drug Administration Act of 2009" which provides for the relevant functions, powers and duties of the agency, including the conduct of PMS activities in the monitoring of health products.

Based on the Certificate of Product Notification issued to the company, any subsequent changes to the information previously submitted to the FDA will render the notification invalid, thus, a new notification will have to be submitted.


In light of the foregoing, the public is advised not to purchase the aforementioned violative cosmetic product. Moreover, the public is advised to always check if a cosmetic product is notified with the FDA through its website ([www2.fda.gov.ph](http://www2.fda.gov.ph)). It has a *Search* feature which may be used by typing in the name of the product before deciding on purchasing and/or using the said product.

All concerned establishments are warned not to distribute violative cosmetic product until they have fully complied with the rules and regulation of the FDA.

All FDA Regional Field Offices and Regulatory Enforcement Units, in coordination with law enforcement agencies and Local Government Units, are requested to ensure that violative products are not sold or made available in the market or areas of their jurisdiction.
