Public Health Warning Against the Purchase and Use of Cosmetic Products Containing Banned Ingredient/s as Reported in the ASEAN Post-Marketing Alert System (PMAS):

- 1. NANA CLEANSING ALCOHOL 80% (BLUE LIQUID)
- 2. NANA CLEANSING ALCOHOL 80% (TRANSPARENT LIQUID)
- 3. NANA HAND GEL ALCOHOL 80%
- 4. NANA HAND ALCOHOL 80%

The Food and Drug Administration (FDA) warns the public from purchasing and using the following unauthorized and adulterated cosmetic products, which tested positive for the presence of **METHANOL**, as reported in the ASEAN Post-Marketing Alert System (PMAS). This ingredient is not allowed to be part of a cosmetic product as per ASEAN Cosmetic Directive (ACD). The table below indicates the particulars of the unauthorized and adulterated cosmetic products:

The aforementioned products have been tested by the Food and Drug Administration, Thailand as part of their post-marketing surveillance activities and results of the laboratory analyses show that these products are not compliant with the technical standards set forth by the ACD.

The aforementioned products were found to contain methanol which is an ingredient not allowed to be part of cosmetic products. Acute and chronic exposure of humans to methanol by inhalation or ingestion may result in visual disturbances, such as blurred or dimness of vision, leading to blindness, and neurological damage, specifically permanent motor dysfunction. Skin contact with methanol can also produce mild to severe dermatitis in humans.

In light of the foregoing, the public is advised not to purchase the aforementioned unauthorized and adulterated products. Moreover, the public is advised to always check if a cosmetic product is notified with the FDA. The FDA website (www.fda.gov.ph) has a Search feature which may be used by typing in the name of the product before purchasing.

All concerned establishments are warned not to distribute unauthorized and adulterated cosmetic products.

All FDA Regional Field Offices and Regulatory Enforcement Units, in coordination with law enforcement agencies and Local Government Units, are requested to ensure that violative products are not sold or made available in the market or areas of jurisdiction.
