1. Shadukang-Rugao 15g
2. Dohongying Raceanisodamine Hydrochloride Injection 1ml:10mg
3. OTC Ibuprofen Sustained –Released Capsules
4. Doxofylline Tablets-Duosuochajian Pian 0.2g [as reflected in the package insert]
5. Ambroxol Hydrochloride Injection 2ml:15mg

The Food and Drug Administration (FDA) advises the public against the purchase and use of the following unregistered drug products:

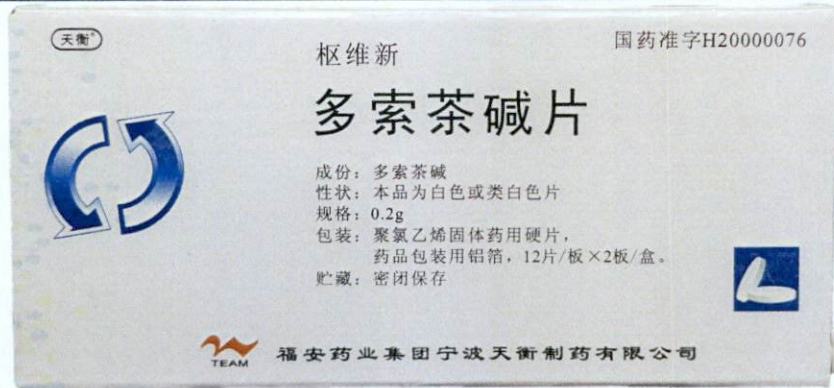

Figure 2. Unregistered drug product



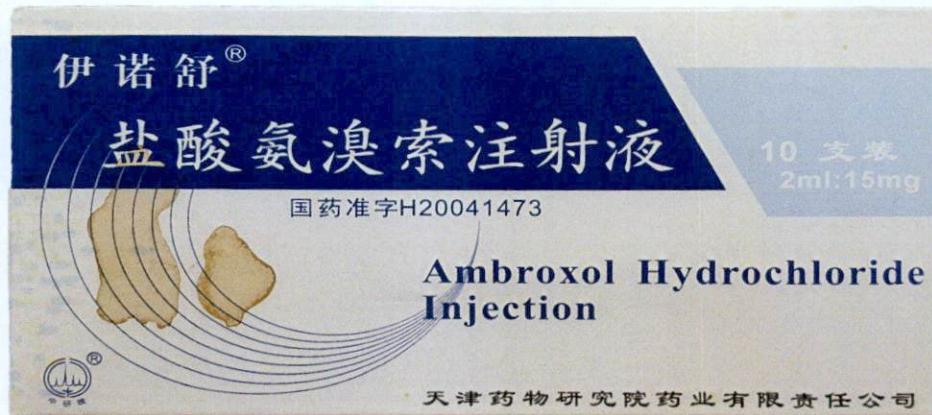


