2. ZX[®] Metformin Hydrochloride Tablets 0.25g
3. KL[®] Levofloxacin Hydrochloride and Sodium Chloride Injection
4. Kelundayaochang[®] Glucose Injection 5% 250ml:12.5g
5. OTC Dezhong[®] Zaoren Anshen Jiaonang [as reflected in the package insert]

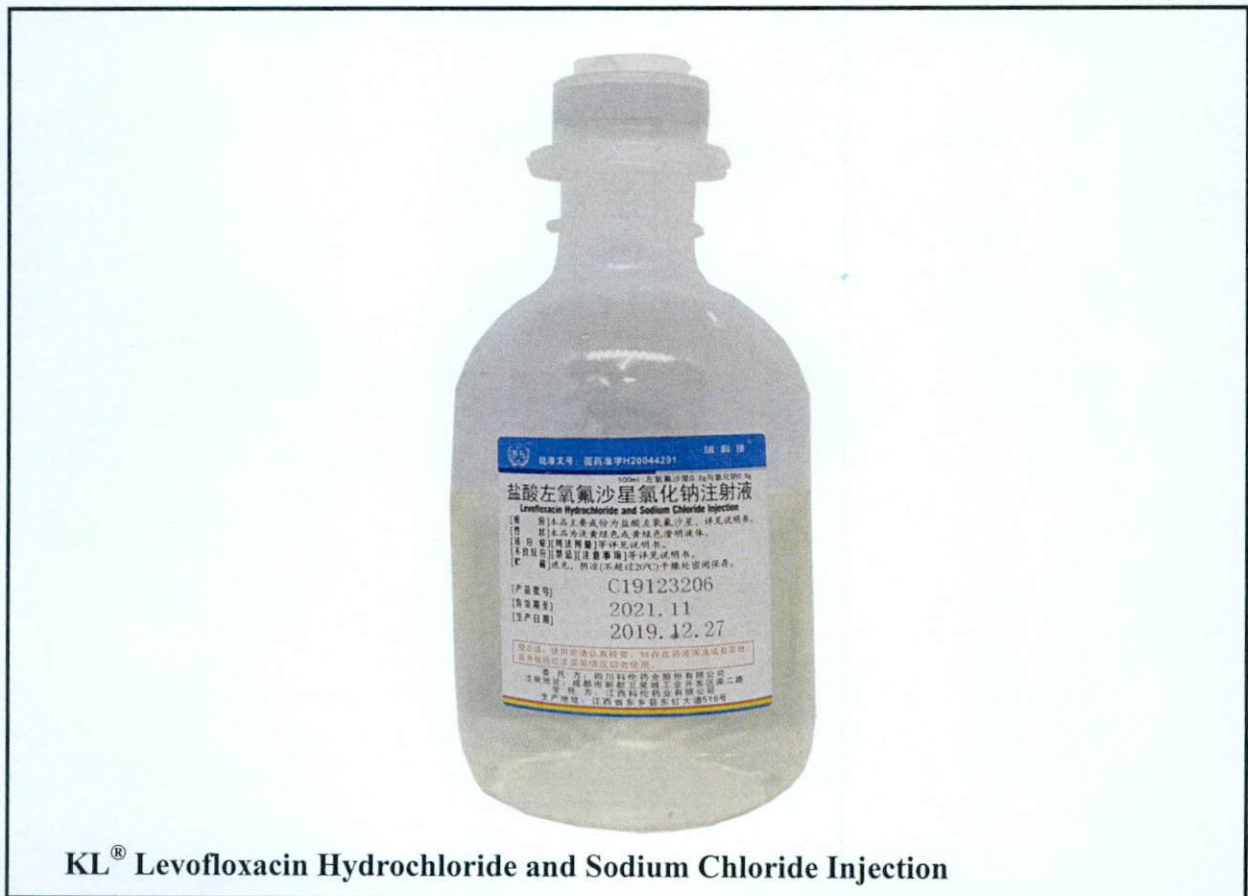
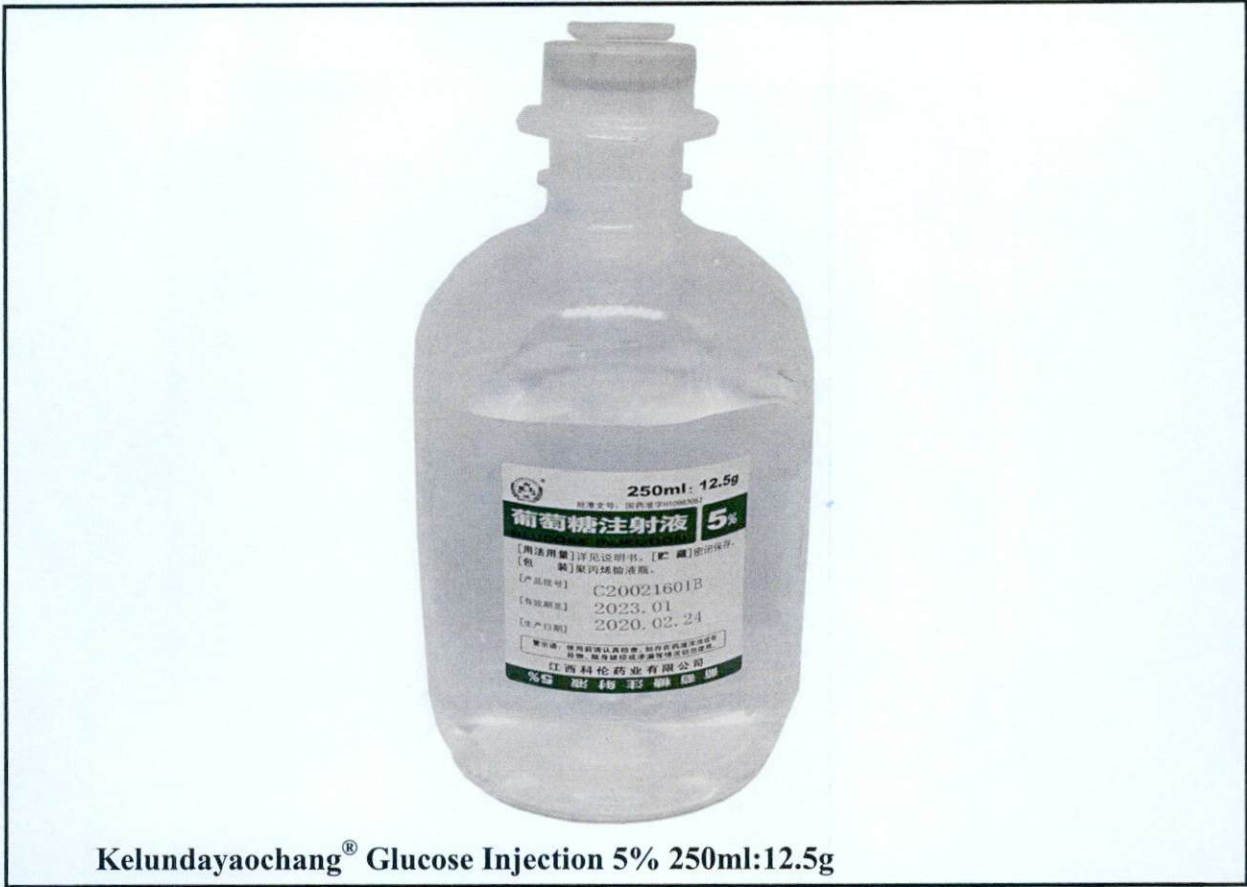


Figure 3. Unregistered drug product


