The Food and Drug Administration (FDA) advises the public against the purchase and use of the following unregistered drug products:

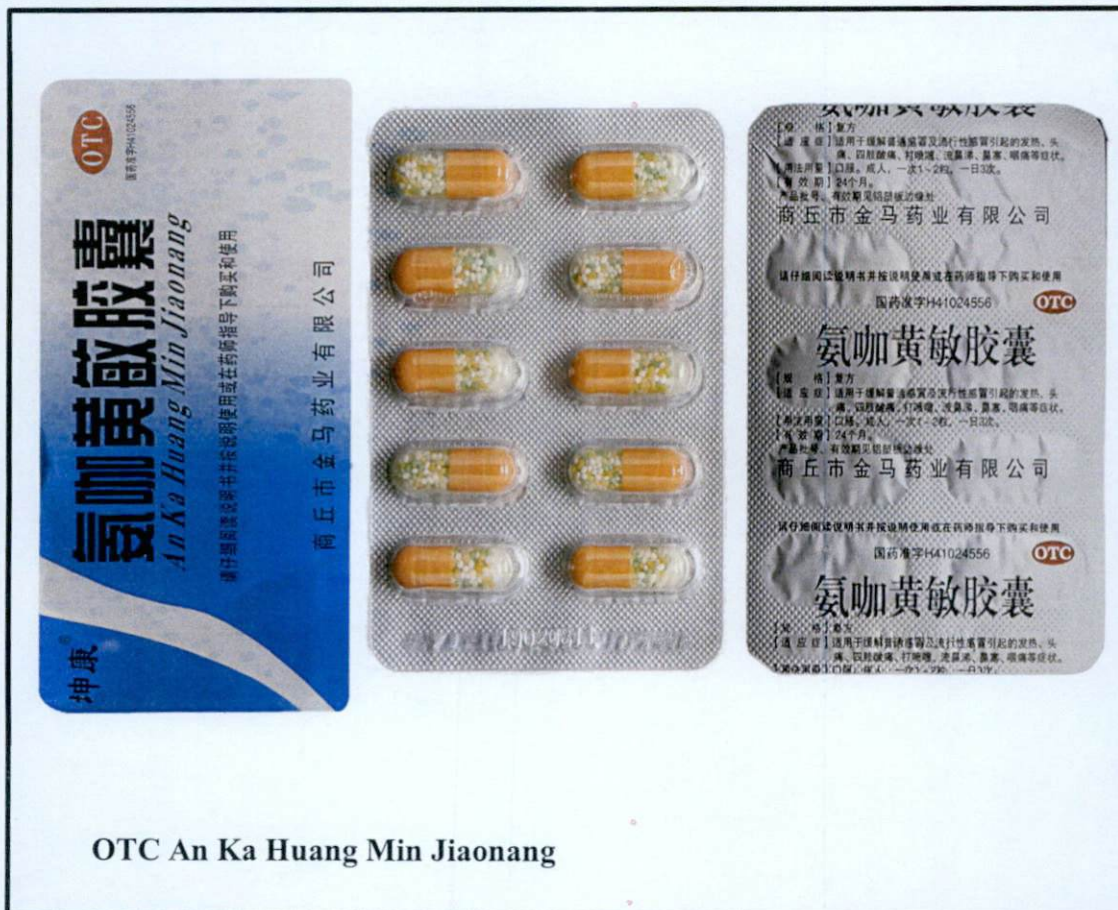


Figure 1. Unregistered drug product





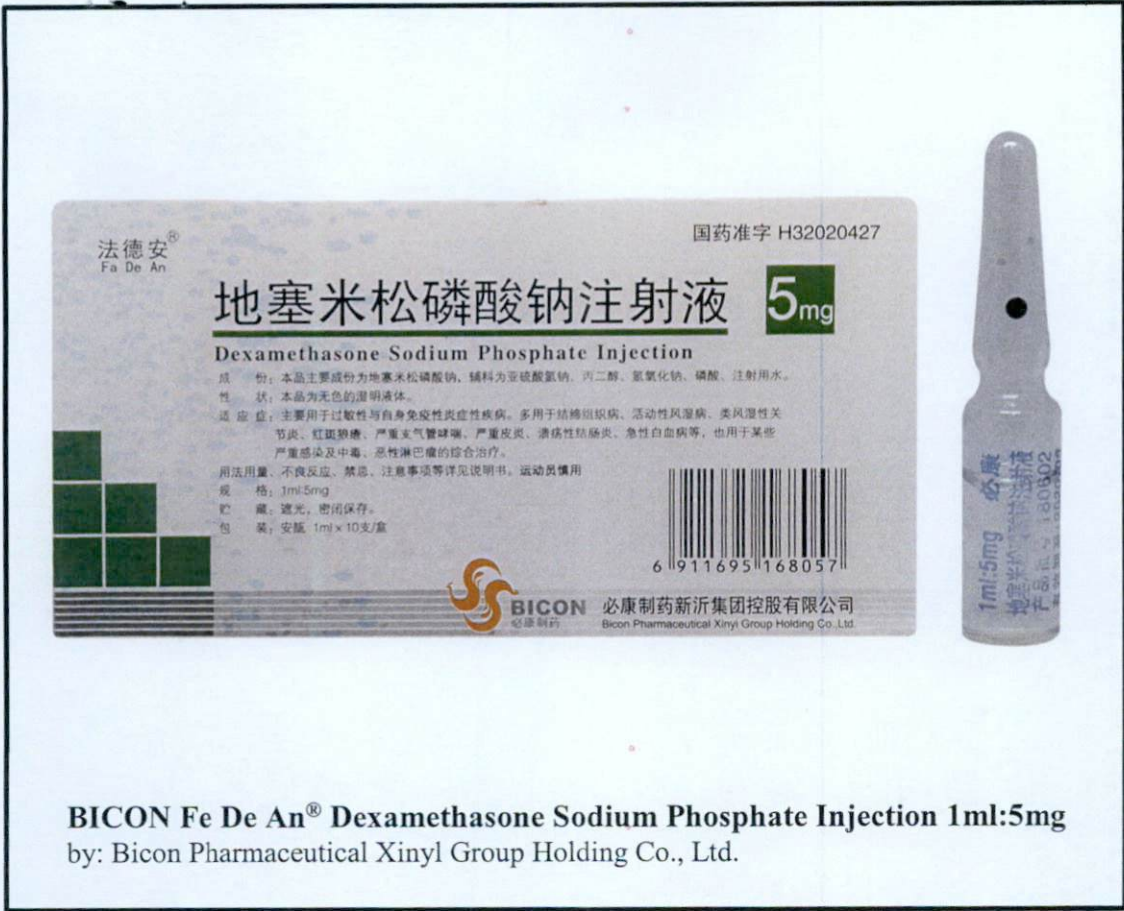


