SUBJECT : OFFICIAL LAUNCHING OF THE FDA E-PORTAL SYSTEM FOR USER ACCOUNT AND FDA CERTIFICATION (PRODUCT BATCH DECLARATION CERTIFICATE) APPLICATIONS FOR VAPOR PRODUCT AND HEATED TOBACCO PRODUCT ESTABLISHMENTS AS PROVIDED BY FDA CIRCULAR NO. 2021-010, PURSUANT TO THE REQUIREMENTS UNDER REVENUE REGULATIONS NO. 7-2021 ISSUED BY THE BUREAU OF INTERNAL REVENUE DATED 18 MAY 2021

This is to inform all concerned stakeholders that the Food and Drug Administration (FDA) is now accepting and processing applications for User Account and FDA Certification (Product Batch Declaration Certificate) for vapor product and heated tobacco product (HTP) establishments through the FDA ePortal System. You may now access the User Account application form through the link bit.ly/ePortal2, and the FDA Certificate application form through the link eportal2.fda.gov.ph. Please be reminded that a User Account credential is needed to access the FDA ePortal System.
