In line with the Bureau Memorandum No. 2009-025 regarding the submission of Pharmacist Clearance prior to the application for a License to Operate as Drug and Cosmetic Establishment and other Certifications, this Office has revised the previous Pharmacist Clearance Form to effectively monitor and verify against our records the applicant pharmacist.

The said clearance shall be attached to the application documents to be submitted by the establishment.

This Circular shall take effect immediately. Failure to submit shall mean non-acceptance of the application documents.
