**SUBJECT : Declaring Unregistered Slimming Products to be Imminently Injurious, Unsafe or Dangerous and Ordering the Recall, Ban or Seizure from Public Sale or Distribution**

The Food and Drug Administration (FDA) has verified that the following slimming products are not registered and not approved or authorized by this Office to be sold in the market:

Further, FDA's findings through laboratory tests showed presence of Amphetamine, Sibutramine or Steroids, either singly or in combination with each other, in the above products. It must be noted that Amphetamine is classified as dangerous drug, while Sibutramine or Sibutramine-containing products were already withdrawn from the market, and Steroids are prescription drugs.

The abovementioned products therefore pose imminent danger or injury to the consuming public and the importation, selling or offering for sale of such is in direct violation of Republic Act No. 9711 or the Food and Drug Administration Act of 2009.

Accordingly, in the interest of protecting public health and safety and pursuant to Section 12 of R. A. No. 9711, the Food and Drug Regulation Officers of this Office (both Central and those in the regions) are hereby ordered to seize immediately the above identified products from all outlets or establishments where they may be found for custody and proper disposition.



All outlets or establishments are warned against selling and/or dispensing the aforementioned products and anyone found selling the said products will be administratively and/or criminally penalized accordingly.

Likewise, the assistance of all local government units are sought in reporting all outlets or establishments found selling the above products and all enforcement agencies are hereby deputized to apprehend and cause the appropriate criminal action against all outlets and establishments found selling the above identified products.
