Job Description:

1. Evaluates and processes documents submitted in connection with the application for the issuance of authorization of a radiation facility;
2. Participates in the development of policies, standards and/or regulations guidelines regarding radiation regulation
3. Evaluates quality assurance programs, shielding designs and calculations of radiation facilities;
4. Conducts radiation protection survey and evaluation and compliance monitoring of radiation facilities and devices;
5. Evaluates personnel radiation dose and facility radiation monitoring reports;
6. Provides technical assistance or advisory services to stakeholders regarding ionizing and non-ionizing radiation devices and facilities;
7. Undertakes research in radiation devices and technology; and
8. Performs other related functions as may be assigned.

All qualified next-in-rank personnel shall be automatically considered candidates for promotion. For all interested FDA regular employees including the qualified next-in-rank candidates, they are required to submit item numbers 1, 2, 3, 5, 6, and 7 listed hereunder, to the FDA-Human Resource Development Division (HRDD). Failure to do so shall be deemed a waiver of their right to be included as candidates for the positions applied for. Further, please be advised that those employees with at least Very Satisfactory (VS) rating in the last two (2) Performance Rating periods shall be considered for promotion.

- 6. Performance Rating for the last two (2) rating periods (for government employees);
- 7. Certificates of trainings attended, if any (in case of managerial/ supervisory trainings for the last 5 years); and
- 8. Latest Appointment and Service Record/Certificate of Employment. (FDA Job Order Personnel need not submit this document)
