INVITATION TO BID

Procurement for the Supply and Delivery of Modular Partition, Furniture including Network Connection and Electrical Cabling

1. The *Food and Drug Administration*, through the Special Account in the General Fund (SAGF) intends to apply the total sum of **Two Million Nine Hundred Twenty Four Thousand Five Hundred Eighty-Fort Pesos and 87/100 (Php2,924,584.87)** being the ABC to payments under the contract for **Procurement for the Supply and Delivery of Modular Partition, Furniture including Network Connection and Electrical**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Food and Drug Administration* now invites bids for the above Procurement Project. Delivery of the Goods is required ***not more than Sixty (60) Calendar days after receipt of Notice to Proceed (NTP)***. Bidders should have completed, within ***Five (5) Years*** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *Food and Drug Administration* and inspect the Bidding Documents at the address given below during ***8:00AM to 5:00PM***.
5. A complete set of Bidding Documents may be acquired by interested Bidders on ***17 – November 2021 to 06 December 2021*** from the given address and website(s) below pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Five Thousand Pesos (Php5,000.00)***. The Food and Drug Administration shall allow the bidder to present its proof of payment for the fees

6. The **Food and Drug Administration** will hold a Pre-Bid Conference¹ on *25 November 2021 at 9:00AM* through video conferencing or webcasting *via Google Meet*: joining info Video call link: <https://meet.google.com/svr-jsom-xor> which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through **manual submission on or before 07 December 2021, 8:30AM** at the Food and Drug Administration BAC Secretariat Room, FDA Annex Bldg. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on *07 December 2021, 9:00AM* at the given address below Food and Drug Administration BAC Secretariat Room, FDA Annex Bldg. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Food and Drug Administration** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
