SUBJECT : Public Health Warning Against the Purchase and Use of the Unregistered Drug Product "MD® Skin Fighter 8 g"

The Food and Drug Administration (FDA) advises the public against the purchase and use of the unregistered drug product:

MD[®] Skin fighter
Net content: 8g

- Using range:** hand / feet ringworm, Body moss, Psoriasis, Moss, Mosses, eczema, Scabies, Blisters, Diaper rash, Skin itching, Ichthyosis, Scleroderma, Mosquito bites, Balanitis, Genital itching, Hemorrhoids, . The skin problems caused by Staphylococcus aureus, Escherichia coli and Candida albicans
- Usage:** topical, take this product covered with hand, foot, body skin, three times a day.
- Note:** Topical, not for the eyes and oral.
- Ingredient:** Sophora flavescens.0.05%,Stemona tubrosa Lour.0.05%, Cnidiummonnieri(L.)Cuss.0.05%,Latin Tille 0.05%, Mnthahaplo-calyx Brip.0.05%,Chlorhexidin⁺ Acetas 0.138%(w/w).
- Producer:** Hong Kong Huayuan Pharmaceutical Development Co., Ltd. Newport Centre, 30 Canton Road, Tsim Sha Tsui, Yau Tsim Mong District, Hong Kong Special Administrative Region.
