As shown in the table, mosquito coils contain different levels of insecticides, which passed the safety and efficacy evaluation of the FDA. The FDA reiterates that mosquito coils were designed to burn slowly to provide optimal protection for several hours. These types of mosquito insecticides should be used only in well-ventilated spaces and should never be used in rooms that do not have windows or ventilations. Consumers are hereby advised to buy only mosquito coils that are registered with the FDA for health and safety reasons. Pesticides in mosquito coils found in unregistered products may be toxic when inhaled or accidentally ingested by toddler or children.
