**SUBJECT: Public Health Warning Against the Use of Unnotified
Cosmetic Products**

The Food and Drug Administration (FDA) advises the public against the purchase and use of the following unnotified cosmetic products:

1. A'S SKIN NATURAL BEAUTY LANOLIN CREAM WITH VITAMIN E
2. DE MONTO LANOLIN CREAM WITH VITAMIN E & COLLAGEN
3. NACOS NATURAL AUSTRALIAN LANOLIN CREAM WITH VITAMIN E & COLLAGEN
4. RONGLAIYA PROFESSIONAL PURE GOLDEN
5. RLY HOMME MEN'S REPAIRING EKE WATER
6. PEARL WHITEN BEAUTIFUL
7. FLOWERONE ELASTIC WHITENING TENDER CREAM
8. QUEEN PIENZEHUANG PEARL CREAM
9. XINFUMANLINGSHUANG ANTI-ACNE AND RENEWAL CREAM
10. FENGSHANGMEI NEW NAIL KIT (NAIL ADHESIVE LS)
11. MISS SEVEN CRACKING NAIL ART KIT (NAIL ADHESIVE WD)
12. MEI JIA ER CHILD BOUTIQUE FAKE NAILS KIT (NAIL ADHESIVE LS)
13. NAIL GLUE WD

The manufacture, importation, exportation, distribution, sale, offer for sale, transportation, promotion and/or advertisement of these non-compliant products is in direct violation of R.A. 9711.

Cosmetic products, prior being placed into the local market, must be duly notified with the FDA by a licensed cosmetic distributor and/or manufacturer. However, if a cosmetic product has not been verified by FDA as in the case of these unnotified products, the use of such products may pose potential health hazards to the consuming public. FDA cannot guarantee their quality and safety. Potential hazards may come from ingredients that are not allowed to be part of a cosmetic product or from the contamination of heavy metals such as lead and mercury. The use of substandard and possibly adulterated cosmetic products may result to adverse reactions including but not limited to skin irritation, itchiness, anaphylactic shock and organ failure.



Thus, the public is advised to always verify if a cosmetic product has been notified with FDA before purchasing it. The FDA website, accessible at <http://www.fda.gov.ph> contains a list of notified cosmetic products which is searchable through its embedded *Search* feature. All consumers are advised to be vigilant of the abovementioned cosmetic products. Retailers of cosmetic products are also warned against selling these products.

In the interest of protecting public health and safety, the FDA Field Regulatory Operations Office (FROO) is ordered to monitor the market for the manufacture, importation, exportation, distribution, sale, offer for sale, transportation, promotion and/or advertisement of the abovementioned cosmetic products. FROO is further ordered to conduct inventory and seal all of the aforesaid unnotified cosmetic products found in the Philippine market, and to effect/conduct seizure of the same in accordance with existing laws, rules and regulations.

Likewise, all local government units and law enforcement agencies are requested to ensure that these products are not sold or made available in their localities or areas of jurisdiction.
