**TO: GENERAL CONSUMING PUBLIC, FIELD REGULATORY OPERATIONS OFFICE OF THE FOOD AND DRUG ADMINISTRATION (FDA), LAW ENFORCEMENT AGENCIES AND LOCAL GOVERNMENT UNITS AND HOUSEHOLD/URBAN PESTICIDE RETAILERS**

**SUBJECT: Public Health Warning Against the Use of Unregistered Household/Urban Pesticide Products (Batch 1)**

The Food and Drug Administration (FDA) advises the public against the purchase and use of the following unregistered household/urban pesticide products:

1. **MG MEGADREAM DURABLE EFFICIENCY INSECTICIDE KILLER**
2. **ANGEL INSECTICIDE AEROSOL**
3. **CRAIE INSECTICIDE MIRACULEUSE**
4. **BUG INSECT REPELLING BRACELET**

The manufacture, importation, exportation, distribution, sale, offer for sale, transportation and/or advertisement of these non-compliant products is in direct violation of R.A. 9711.

Household/urban pesticide products, prior to being placed into the local market, must be duly registered with the FDA by a licensed household/urban pesticide distributor and/or manufacturer. However, if a household/urban pesticide product has not been evaluated by FDA as in the case of these unregistered products, the use of such products may pose potential health hazards to the consuming public. FDA cannot guarantee their quality, efficacy and safety. Such products are harmful, toxic and may pose imminent danger to human and animal health. The use of substandard and possibly adulterated household/urban pesticide products may result to adverse reactions including but not limited to skin irritation, itchiness, anaphylactic shock, respiratory disorders, endocrine complications, brain damage and organ failure.

Thus, the public is advised to always verify if a household/urban pesticide product has been registered with the FDA before purchasing it. The FDA website, accessible at <http://www.fda.gov.ph> contains a list of registered household/urban pesticide products which is searchable through its embedded *Search* feature. All consumers are advised to be vigilant of the abovementioned household/urban pesticide products. Retailers of household/urban pesticides are also warned against selling these products.



Consumers are further reminded to:

- Buy household/urban pesticide products from reputable stores or dealers;
- Never buy pesticides that do not have instructions written in Filipino or English;
- Ensure the product has proper label that includes FDA registration number;
- Make sure the label clearly indicates the active ingredients of the product.

In the interest of protecting public health and safety, the FDA Field Regulatory Operations Office (FROO) is ordered to monitor the market for the manufacture, importation, exportation, distribution, sale, offer for sale, transportation, promotion and/or advertisement of the abovementioned household/urban pesticide products. FROO is further ordered to conduct inventory and seal all of the aforesaid unregistered household/urban pesticide products found in the Philippine market, and to effect/conduct seizure of the same in accordance with existing laws, rules, and regulations.

Likewise, all local government units and law enforcement agencies are requested to ensure that these products are not sold or made available in their localities or areas of jurisdiction.
