SUBJECT: Public Health Warning Against the Use of Unnotified Cosmetic Products (Batch 13)

The Food and Drug Administration (FDA) advises the public against the purchase and use of the following unnotified cosmetic products whose particulars/details are provided in the attached annex:

1. **AICHUN BEAUTY HIP UP CREAM COFFEE & CHILLI**
2. **ANSINA WHITENING SUNBLOCKING CREAM SPF 38 PA+++**
3. **ASUDJOR® WHITENING CREAM**
4. **KUSTIE DERMO-EXPERTISE BEAUTY WOMEN SLIM ESSENCE HOT CREAM**
5. **PAPAYA WHITENING PEELING GEL**
6. **QUICKLY CHANGE LIP EASY LIPSTICK**
7. **AIFEIYA CC CREAM NATURAL SKIN TONE WITH SOFT AND MOIST APPLICATION SPF 36 PA++**
8. **A & W SILTY FINE AND SMOOTH 12 COLOR EYE SHADOW NO. 619B**
9. **KISS BEAUTY PARIS FRANCE LOVE BY HEART BLUSHER**
10. **PROFUSION COLOUR ME GLOW PEARL EYESHADOW**

FDA post-marketing surveillance (PMS) activities have verified that the abovementioned cosmetic products have not gone through the verification process of the agency and have not been issued the proper authorization in the form of acknowledged cosmetic notifications. Pursuant to Republic Act No. 9711, otherwise known as the "Food and Drug Administration Act of 2009", the manufacture, importation, exportation, sale, offering for sale, distribution, transfer, non-consumer use, promotion, advertising or sponsorship of health products without the proper authorization from FDA is prohibited.

Accordingly, because unnotified cosmetic products have not gone through the verification process of the FDA, the agency cannot guarantee their quality and safety. The use of such violative products may pose potential health hazards to the consuming public. Potential hazards may come from ingredients that are not allowed to be part of a cosmetic product or from the contamination of heavy metals such as mercury especially in whitening cosmetic products. The use of substandard and possibly adulterated cosmetic products may result to adverse reactions including but not limited to skin irritation, itchiness, anaphylactic shock and organ failure.

In light of the above, the public is advised not to purchase the aforementioned violative products. Moreover, the public is also advised to be vigilant against cosmetic products that might not be duly notified with FDA. Always check if a cosmetic product has been notified




with FDA before purchasing it by making use of the embedded *Search* feature of the FDA website accessible at www.fda.gov.ph.

All concerned establishments are warned not to distribute the above-identified violative cosmetic products until they have already been covered by the appropriate authorization (cosmetic notification), otherwise, regulatory actions and sanctions shall be strictly pursued.

All Local Government Units (LGUs) and Law Enforcement Agencies (LEAs) are requested to ensure that these products are not sold or made available in their localities or areas of jurisdiction.
