SUBJECT : Public Health Warning Against Unapproved and Misleading Advertisements and Promotion of Quantumin Plus

The Food and Drug Administration (FDA) warns the public against the following unapproved, false, and misleading advertisements and promotion of **Quantumin Plus**:
