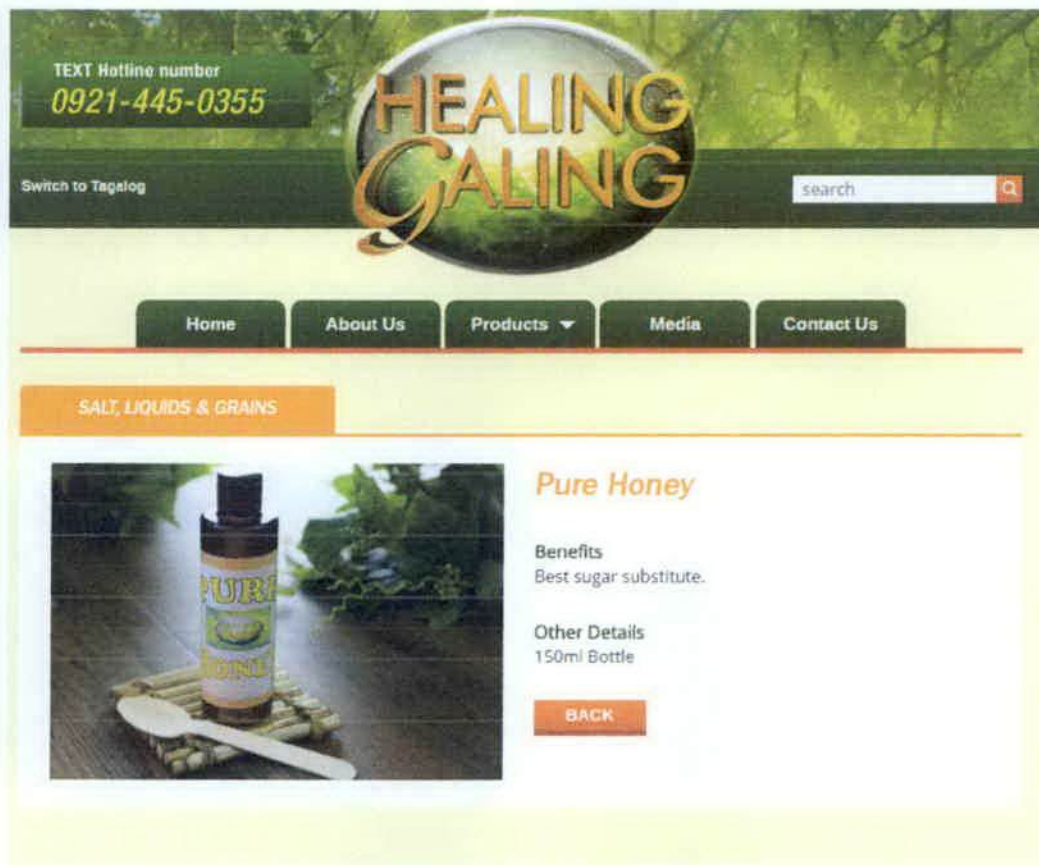


Figure 8. Unregistered Healing Galing Pure Honey
