**SUBJECT: Public Health Warning Against the Use of Cosmetic Product Containing Banned Ingredient/s (Batch 9)**

The Food and Drug Administration (FDA) advises the public against the purchase and use of the adulterated cosmetic product **BEAUCHE REJUVENATING CREAM** which tested positive for the presence of **HYDROQUINONE** and **TRETINOIN**, ingredients that are not allowed to be part of a cosmetic (refer to the image below for the product particulars/details):


