Subject:

Lifting of Registration Amnesty Granted for Do-It-Yourself and Hobby Products, Classified as Household/Urban Hazardous Substances

(HUHS)

On 02 May 2013, the Food and Drug Administration (FDA) issued FDA Circular No. 2013-013, which granted registration amnesty for non-compliant Do-It-Yourself and Hobby Products classified as Category IV Household/Urban Hazardous Substances (HUHS) for a period of one year, ending on **02 May 2014**.

Concerned manufacturers and distributor/importers are strongly advised to file their applications with the Center for Cosmetic Regulation and Research (CCRR) before 02 May 2014 to avoid penalties and sanctions, as provided by Republic Act No. 9711, otherwise known as the FDA Act of 2009. After the said date, the sale, offer for sale or use, import, export, advertisement, or promotion of unregistered products shall be prohibited.

The FDA-CCRR has online notification (registration) application (www.fda.gov.ph) to facilitate application and submission of documentary requirements, as per requirement of FDA Memorandum Circular No. 2013-045 on HUHS notification scheme (http://www.fda.gov.ph/attachments/article/121441/FMC2013-045.pdf).

Only those establishments that have valid License to Operate (LTO) can apply for product registration. Based on the FDA-CCRR existing records, only six (6) establishments are licensed with the FDA and there are only thirty-two (32) Do-It-Yourself and Hobby Products registered with the FDA, and these are as follows:










