SUBJECT: Voluntary Recall of (1) JIF Creamy Peanut Butter 12 oz and 16 oz, (2) JIF Extra Crunchy Peanut Butter 16 oz, and (3) JIF Reduced Fat Peanut Butter 16 oz, due to potential *Salmonella* contamination

The Food and Drug Administration on 25 May 2022 was notified by Sysu International, Inc. of its initiated voluntary recall of **JIF Creamy Peanut Butter**, **JIF Extra Crunchy Peanut Butter** and **JIF Reduced Fat Peanut Butter** due to potential *Salmonella* contamination, implicating the following respective lot numbers:


The recall is being initiated after Sysu International, Inc. local distributor of the implicated products received a product recall notice from J.M. Smucker Co., USA, manufacturer of JIF Peanut Butter products. J.M. Smucker Co. has announced a voluntary recall of select JIF products sold in the U.S. and Canada due to potential *salmonella* contamination.

This recall only applies to the affected lot numbers and no other batches of JIF Peanut Butter products are affected by this recall.
