The Center for Cosmetics and Household/Urban Hazardous Substances Regulation and Research (CCHUHSRR) will be holding a virtual consultation on the proposed issuance, provisionally entitled “Guidelines on the Filing and Submission of Acceptable Variations on Protocols and Non-standard Protocols for the Review and Pre-Approval by the Food and Drug Administration Prior to the Conduct of Bio-efficacy Test Studies of Household Pesticides for the Purposes of Securing a Certificate of Product Registration”.

The proposed issuance aims to improve the regulatory compliance of pesticide registration applications and facilitate the same through the establishment of a pathway for the review and pre-approval of non-standard and modified bio-efficacy test protocols.

All concerned stakeholders, including Household/Urban Pesticide (HUP) Manufacturers, Distributors and Traders, and other HUP-related establishments, are invited to participate by registering in the link provided below.
