## Invitation to Bid

## PROCUREMENT ON THE CONSULTANCY SERVICE FOR THE ISO/IEC 17020:2012 ACCREDITATION

- The Food and Drug Administration, through the Maintenance and Other and Operating Expense (MOOE) intends to apply the sum of <u>Eight Hundred Sixteen Thousand Two Hundred Fifty Pesos Only (Php816,250.00)</u> being the Approved Budget for the Contract (ABC) for the <u>Procurement of the Consultancy Service for the ISO/IEC 17020:2012 Accreditation</u>. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- 2. The Food and Drug Administration now calls for the submission of eligibility documents for the **Procurement of the Consultancy Service for the ISO/IEC 17020:2012 Accreditation.**
- 3. Eligibility documents of interested consultants must be duly received by the SLC-BAC Secretariat not later than 01 August 2022 until12:00 noon at 7<sup>th</sup> Kingston Excell Bldg., Civic Drive Filinvest City, Alabang Muntinlupa City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- 4. Interested bidders may obtain further information from SLC-BAC Secretariat at 7<sup>th</sup> Kingston Excell Bldg Civic Drive Filinvest City, Alabang, Muntinlupa City and inspect the Bidding Documents from 8:00am to 5:00pm Monday to Friday or call at 09171542179 Likewise, visit the FDA website at www.fda,gov.ph or email at slc-bacsec@fda.gov.ph.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 09 July 2022 from the SLC-BAC Secretariat.
  - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The SLC-BAC shall draw up the short list of consultants/certifying body from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The criteria and rating system for short listing are:

7. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens'/sole proprietorships, cooperatives, and partnerships or organization with at least sixty percent (60%) interest of outstanding capital stock belonging to citizens of the Philippines.

The **Food and Drug Administration** SLC-BAC will hold a Pre-Bid Conference<sup>1</sup> on 20 July 2022 at 9:30am through video conferencing or webcasting via Google meet: joining info Video call link: https://meet.google.com/mec-vhiv-cmc?hs=122&authuser=1 which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through manual submission not later than 01 August 2022 until 12:00nn at the Food and Drug Administration BAC Secretariat Room, FDA Annex Bldg. Late bids shall not be accepted.

Bid opening shall be on 01 August 2022 at 1:30pm at the given address below Food and Drug Administration SLC-BAC 7th Kingston Excell Bldg., Civic Drive Filinvest City, Alabang, Muntinlupa City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

- 8. The Procuring Entity shall evaluate bids using the Quality Based Evaluation/Selection (QBE), procedure. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- 9. The contract shall commence upon receipt of Notice to Proceed (NTP) and ends with the post evaluation and submission of technical and financial documentation and evaluation reports and its supporting documents.
- 10. The FDA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
