The Food and Drug Administration (FDA) warns all healthcare professionals and the general public **NOT TO PURCHASE AND USE** the following unnotified medical device products:

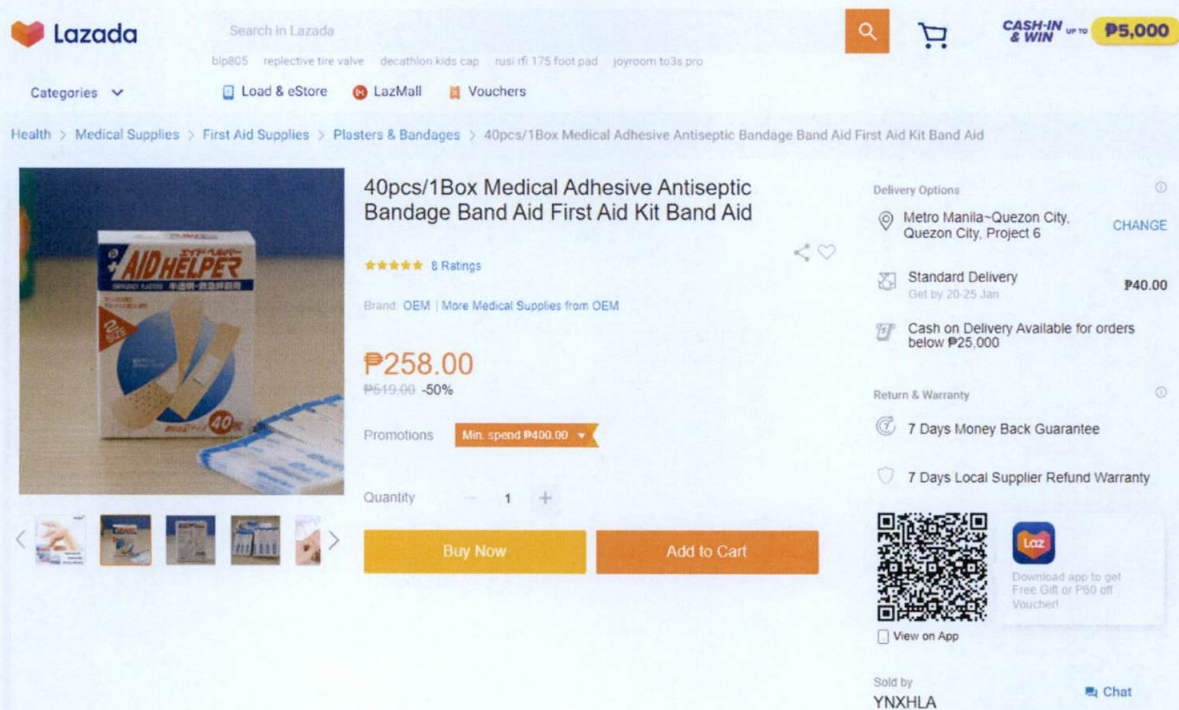


Figure 1. Unnotified AID Helper Emergency Plaster advertised at Lazada.com.ph

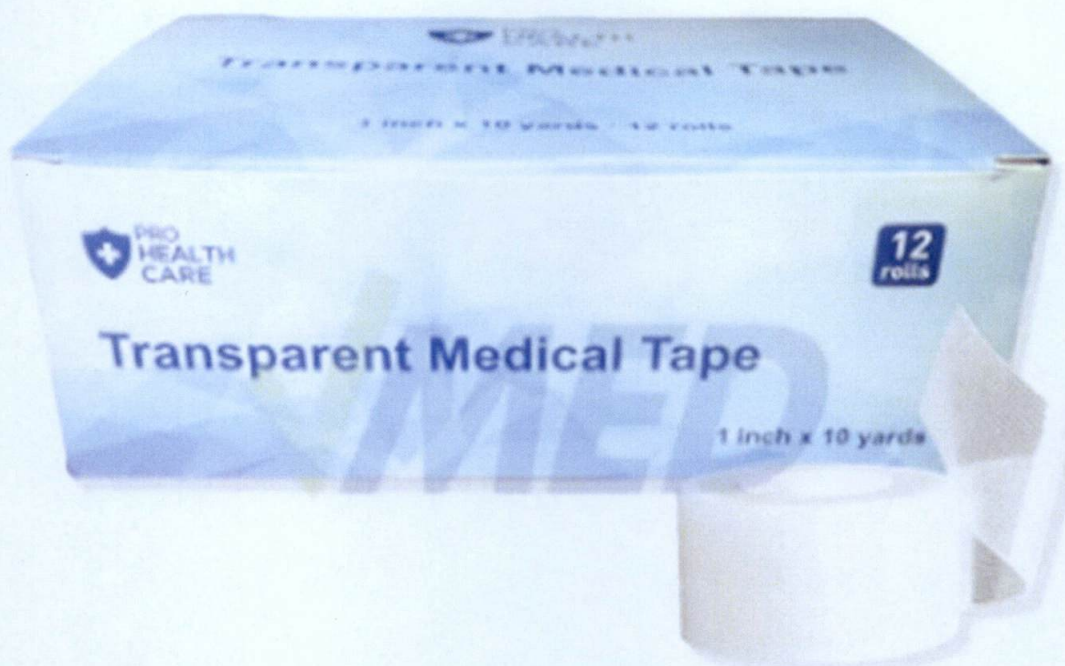


Figure 4. Unnotified Pro Health Care Transparent Medical Tape advertised at Lazada.com.ph

The FDA verified through post-marketing surveillance that the above mentioned medical device products are not notified and no corresponding Product Notification Certificate have been issued. Pursuant to the Republic Act No. 9711, otherwise known as the “Food and Drug Administration Act of 2009”, the manufacture, importation, exportation, sale, offering for sale, distribution, transfer, non-consumer use, promotion, advertising or sponsorship of health products without the proper authorization is prohibited.

Since these unnotified medical device products have not gone through the evaluation process of the FDA, the agency cannot assure its quality and safety.

All concerned establishments are warned not to distribute, advertise, or sell the said violative medical device products until the Product Notification Certificate are issued, otherwise, regulatory actions and sanctions shall be strictly pursued. You may also look for the FDA Notification number on the product label in the form of CMDN-xxx.


