- 5. Provides technical assistance related to the radiation health component of the national radiological emergency preparedness and response plan;
- 6. Provides advisory services to stakeholders regarding radiation regulation;
- 7. Supervises the health technology assessments activities on radiation devices and technology;
- 8. Performs other related functions as maybe assigned.
