All concerned establishments are warned not to distribute, advertise, or sell the said violative food supplement until CPR is issued, otherwise, regulatory actions and sanctions shall be strictly pursued. All Law Enforcement Agencies and Local Government Unit are requested to ensure that this product is not sold or made available in the market or areas of jurisdiction.

The Bureau of Customs is urged to restrain the entry of the unregistered imported products.
