Interested bidders, who have a legitimate business permit, BIR certificate and/or other pertinent requirements shall be allowed to participate in the **ON-SITE PUBLIC**



AUCTION/SALE via VIVA VOCE on 27 September 2022, Wednesday, 9:30 am, in the FDA – General Services Division (GSD), FDA GSD New Building, Filinvest Corporate City, Civic Drive, Alabang, Muntinlupa City. FDA reserves the right to deny participation of late bidders.

Public Auction/Sale, offered via Viva Voce, below the appraised value or minimum floor price shall be DISQUALIFIED. Award shall be made to the highest bidder. In case of a tie, the FDA-GSD will resort to non-discretionary criteria (toss coin or draw lots) to determine the winning bidder.

If the winning bidder refuses to accept the award, the next highest bidder shall be awarded the bid. However, any bidder who refuses to accept the award **SHALL BE REQUIRED TO PAY THE DIFFERENCE BETWEEN SAID BIDDER'S AND THAT OF THE NEXT HIGHEST BIDDER**, without prejudice to FDA-IDC's other courses of action and remedies open to it.

A Bid Bond amounting to *ten percent (10%) of the minimum floor price PER LOT AND/OR but not less than 10% the total of the two (2) Lots*, in the form of **Cash**, must be submitted and placed inside the sealed mailing envelope labelled with the name of the company. Interested Bidders with **no corresponding Bid Bond or less than 10% of the minimum floor price submitted shall be disqualified.**

One-time payment in cash shall be made within five (5) calendar days from the date of receipt of the Notice of Award. An Official Receipt shall be issued by the FDA Cashier covering the payment made by the winning bidder.

The winning bidder and/or his authorized representative shall be given **ten (10) calendar days** from receipt of the Notice to Proceed or Release Order, to pick-up and haul the property from FDA. otherwise, a storage fee in the amount equivalent to **1% of the total unwithdrawn item's or Five Hundred Pesos (P500.00) whichever is higher** shall be charged against him per day of delay. Failure to claim the property **within thirty (30) days** shall be subject to cancellation of the award/contract and the ownership of the awarded property shall automatically revert to the FDA. All money received in connection with the sale shall be forfeited in favor of the FDA.

Expenses incidental to the pick-up/hauling of the property shall be borne by the winning bidder; and in case the winning bidder fails to complete the pick-up/hauling of the property within the prescribed period, the award shall be revoked/cancelled. The next highest bidder shall be awarded the bid.

The Bid Bond shall be forfeited in favor of FDA in the following instances:

- 1.1 If the winning bidder refuses to accept the award; In case the winning bidder fails to make the payment within the prescribed period;


- 1.2 If the winning bidder fails to complete the pick-up/hauling of the property within the prescribed period; and
- 1.3 The Bid Bond shall be returned to the concerned bidder/s after the winning bidder has completed the pickup/hauling of the properties.

Failure of bidding shall be declared in the following instances:

1. If prospective bidders are declared ineligible;
2. No bids are received;
3. All bids fail to comply with the bid requirements;
4. All bids are below the floor price; and
5. The winning bidder refuses to accept the award or the winning bidder fails to make the payment as required.

In case of failure of the first and second auction/bidding, the FDA shall dispose unserviceable and/or obsolete equipment through **negotiation in compliance with COA rules and regulations.**
