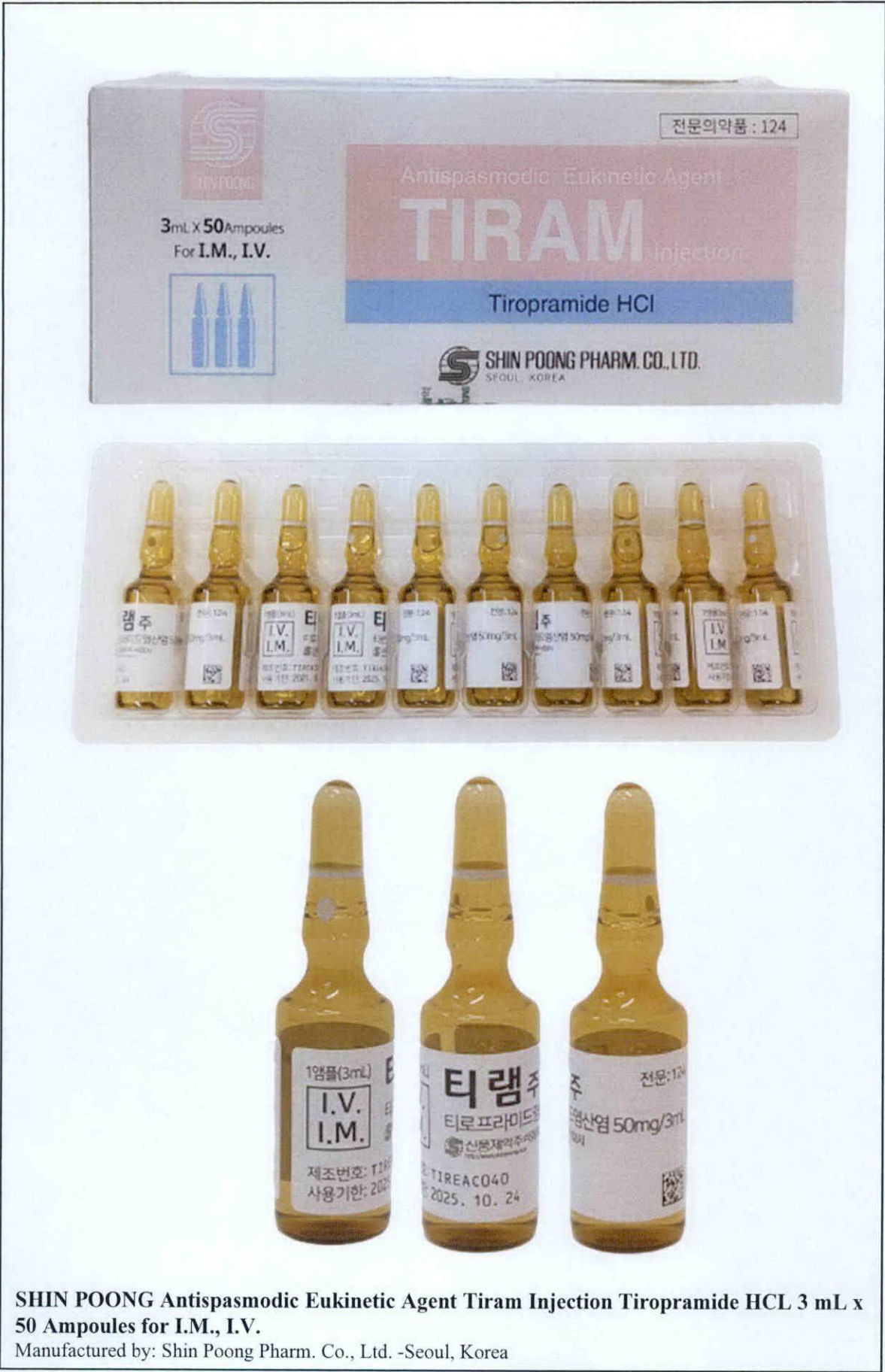

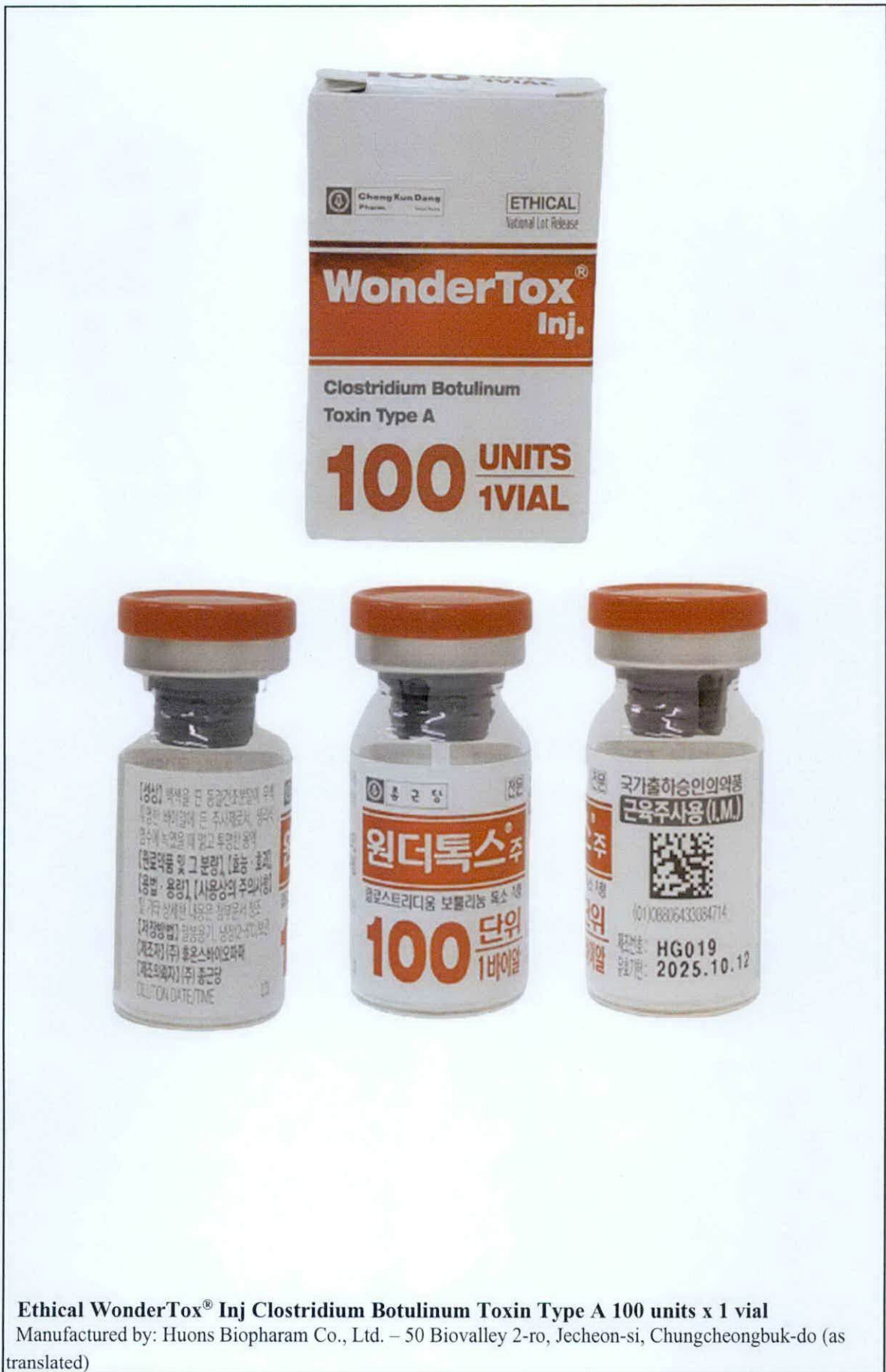

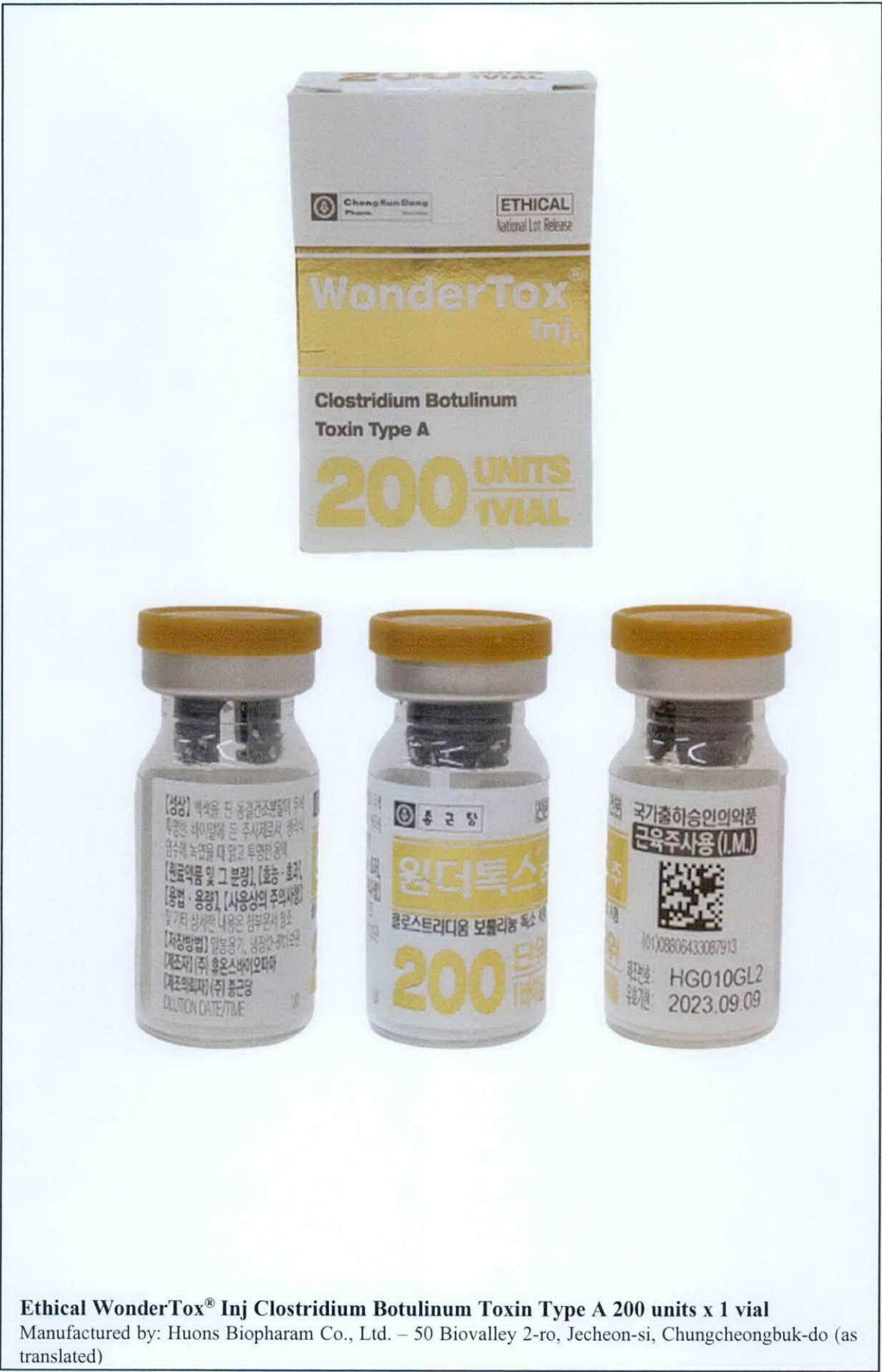

Figure 2. Unregistered drug product



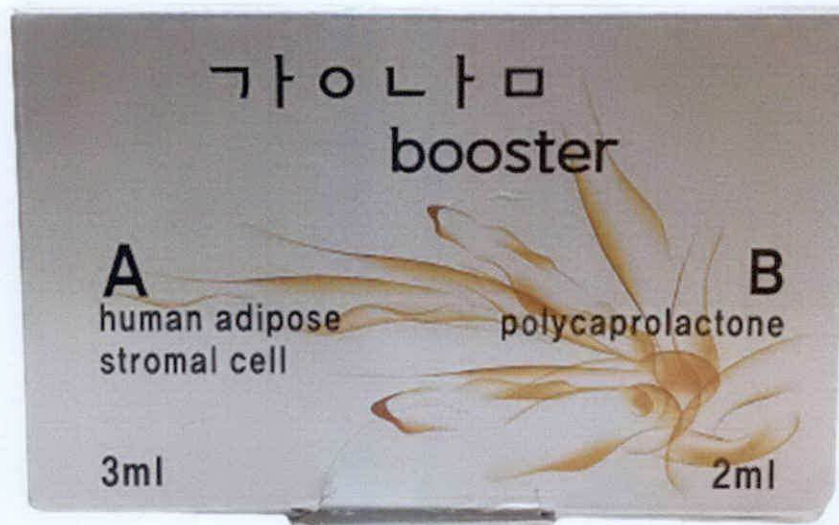
